一、為鼓勵本校教師(含編制外專任教學人員)積極發表研究論文於優良學術期刊、參加藝術與設計類國際競賽，提昇學術研究風氣及校譽，特設置本要點。

二、申請資格：

(一)本校教師從事學術研究活動，以本校具名發表優良學術期刊論文(SCI、SCIE、SSCI、A&HCI、TSSCI、THCI)或發表於本校 Journal of Innovative Technology 期刊，始適用本要點。

(二)本校教師以本校具名參加附表一所列藝術與設計類國際競賽，且成績優異者。

三、獎勵金來源及計算：獎勵金來源為本校自籌收入經費及校務基金支應並依「國立雲林科技大學校務基金自籌收入收支管理辦法」第三條第一項第三款教學及學術研究獎勵規定辦理。本要點併同「國立雲林科技大學教師承接計畫獎勵要點」之獎勵金總和與「國立雲林科技大學高教深耕計畫彈性薪資支給作業要點」核發之彈性薪資擇優支給，擇優計算由研究發展處、校發中心及相關單位統合辦理。

四、獎助原則：

(一)獎勵點數計算公式：每篇論文點數= $B+X^L+Ic+Mc$

B (Basic Points)：基本獎勵點數

X：調整倍率

L：學門排名

Ic (International Collaboration)：國際合作點數(符合第二點第一款，且包括本校本師及外師或與其他國際教研機構合作發表論文者)

Mc：SSCI 額外點數

(二)獎勵點數：B、Mc(屬 SSCI 期刊者)各別均為三，X 為二，校內本師及外師合作發表論文者 Ic 為二，本校教師與其他國際教研機構合作發表論文者 Ic 為四，二者兼具時 Ic 為六。L 則視影響係數而定，於學門排名第 1 或前百分之五(含)者，則該篇 L 為五；排名介於百分之五(不含)至百分之二十五(含)者，則該篇 L 為四；排名介於百分之二十五(不含)至百分之五十(含)者，則該篇 L 為三；排名介於百分之五十(不含)至百分之七十五(含)者，則該篇 L 為二；排名百分之七十五(不含)以後者，則該篇 L 為一；無影響係數者，L 為零。

- (三)論文發表日期以正式出版年度為基準，並以該論文發表年度之前一年度於 Journal Citation Reports 資料庫之各學門排名 Journal Impact Factor 擇優為計算標準。若該篇論文發表於「不鼓勵期刊或出版社清單」，出版日期為 2024 年 1 月 1 日至 2025 年 12 月 31 日，依本要點下列第(四)款計算之點數乘以折減係數 0.5；出版日期為 2026 年 1 月 1 日(含)以後者，不予計算獎勵點數。「不鼓勵期刊或出版社清單」依研發處之公告辦理。
- (四)列名第一作者或通訊作者，按本點公式計算獎勵點數；以本校名義與校外教研機構合作發表論文者，且列名第二、三作者，其獎勵點數減半，列名第四作者以後者，其獎勵點數減為十分之一。若有多位通訊作者，將依其通訊作者人數之比率計算獎勵點數，若多位通訊作者為本校師生，其中本校師生合併以 1 人計算之。上述點數擇優計算。
- (五)教師創設作品參加藝術與設計類國際競賽，視獎項種類依附表一核予獎勵點數；教師指導本校學生榮獲前揭競賽獎項者，其獎勵點數減半。
- (六)發表於 SCIENCE 或 NATURE 等期刊者個別獎勵（不以獎勵點數計算），每篇論文獎勵金五十萬元。
- (七)每篇論文或得獎作品限獎勵一次。
- (八)獎勵金按年度預算總額調整計算，每篇以不低於六千元為原則（獎勵點數經折減者不在此限），含補充保費學校公提部分。

五、除上述獎勵外，亦得由各單位產學合作研究計畫管理費及節餘款項下另訂辦法補助，並依本校「各單位產學合作研究計畫管理費及節餘款支用要點」辦理。

六、申請程序：

- (一)符合第二點第一款之申請人，由研究發展處原則於每年五月自本校教師著作目錄系統中匯出上一年度著作列表並計算獎勵點數後，送請各系所辦公室轉交申請人確認，以辦理獎勵事宜；前開匯出資料為研究發展處審查依據，申請人不得逕行修改或補件申請獎勵。
- (二)符合第二點第二款之申請人，必須檢附申請表（表二）及得獎相關證明，送交研究發展處申請及審查。
- (三)若有二位以上教師同時列名作者時，不得重複提出申請。

七、屬於學術期刊之信函、短文或其他論文，授權研究發展處審查。

八、於學術期刊發表論文，未遵照政府規範使用正式國名者，致我國格遭矮化或國家名稱被誤用依規定不予獎勵，如：Taiwan, China、(城市名), China、(學術機構名), China、People's Republic of China，或是 Chinese Taipei 等。另申請人發表的論文，如具多重隸屬機構(Multi-affiliation authorships)且未依本校規定辦理兼職、借調、合聘、合作、休假研究、進修等校內行政程序核准在案者，則該論文不予獎勵。以不實文件、偽造文書或其他有違學術倫理導致校譽受損者，本校得追回所有之支給金額，並依相關法規處置。

九、本要點經行政會議與校務基金管理委員會通過，並陳請校長核定，修正時亦同。

I. To encourage Yuntech teachers (including non-tenured teaching staff) to actively publish research papers in excellent academic journals and participate in international competitions in art and design, and to enhance the academic research atmosphere and the reputation of the university, these guidelines are established.

II. Eligibility for application:

- (1) Teachers of Yuntech who engage in academic research activities and publish excellent academic journal papers (SCI, SCIE, SSCI, A&HCI, TSSCI, THCI) under the name of Yuntech or publish in the Journal of Innovative Technology of Yuntech are eligible under these guidelines.
- (2) Teachers of Yuntech who participate in the international competitions in the fields of art and design listed in Appendix I under the name of Yuntech and achieve excellent results.

III. Source and Calculation of Incentive Funds: The source of incentive funds is Yuntech's self-raised income and the university fund, which are managed in accordance with the provisions for teaching and academic research incentives in Subparagraph 3, Paragraph 1, Article 3 of the "National Yunlin University of Science and Technology Self-Raised Income and Expenditure Management Regulations".

IV. Principles of incentives:

- (1) Calculation formula for incentive points: Each paper point = $B + X^L + I_c + M_c$
B (Basic Points): Basic incentive points
X: Adjustment factor
L: Field ranking
I_c (International Collaboration): International collaboration points (meeting the first subparagraph of the second point, and including domestic and foreign teachers of Yuntech or collaboration with other international educational and research institutions in publishing papers).
M_c: Additional SSCI Points
- (2) Reward points: B, M_c (belonging to SSCI journals) are each three, X is two, domestic and

foreign teachers of Yuntech collaborating to publish papers L_c is two, Yuntech teachers collaborating with other international educational and research institutions to publish papers L_c is four, and when both are present, L_c is six. L depends on the impact factor, if the discipline ranking is 1st or within the top 5% (inclusive), then the L for that paper is five; if the ranking is between 5% (exclusive) and 25% (inclusive), then the L for that paper is four; if the ranking is between 25% (exclusive) and 50% (inclusive), then the L for that paper is three; if the ranking is between 50% (exclusive) and 75% (inclusive), then the L for that paper is two; if the ranking is after 75% (exclusive), then the L for that paper is one; if there is no impact factor, L is zero.

- (3) The publication date of the paper shall be based on the official year of publication, and the Journal Impact Factor ranking of each discipline in the Journal Citation Reports database of the year preceding the publication year shall be adopted on a best-case basis as the calculation standard. If the paper is published in the "List of Discouraged Journals or Publishers", with a publication date from January 1, 2024 to December 31, 2025, the points calculated according to the following subparagraph (4) of these guidelines are multiplied by a reduction factor of 0.5; if the publication date is after January 1, 2026 (inclusive), no reward points will be calculated. The "List of Discouraged Journals or Publishers" is handled according to the announcement of the Office of Research and Development.
 - (4) If listed as the first author or corresponding author, the reward points are calculated according to this formula; if a paper is published in collaboration with an external educational and research institution under the name of Yuntech, and listed as the second or third author, the reward points are halved, if listed as the fourth author or later, the reward points are reduced to one-tenth. If there are multiple corresponding authors, the reward points will be calculated according to the ratio of the number of corresponding authors, if multiple corresponding authors are Yuntech teachers or students, they are combined and counted as one. The above points are calculated on a preferential basis.
 - (5) Teachers create works to participate in international competitions in art and design, and award points according to Appendix I depending on the type of award; teachers guide Yuntech students to win the aforementioned competition awards, and their incentive points are halved.
 - (6) Those who publish in journals such as SCIENCE or NATURE are individually rewarded (not calculated by incentive points), and each paper is awarded 500,000 dollars.
 - (7) Each paper or award-winning work is limited to once.
 - (8) The incentive money is adjusted according to the total annual budget, and each paper is not less than 6,000 yuan in principle (those whose incentive points are reduced are not limited to this), including the part of the supplementary premium that the school publicly provides.
- V. In addition to the above incentives, additional subsidies may be provided from the management fees and surplus funds of the industry-academia cooperation research projects of each unit, and

they shall be handled in accordance with the "Guidelines for the Use of Management Fees and Surplus Funds of Industry-Academia Cooperation Research Projects of Each Unit of Yuntech".

VI. Application procedure:

- (1) Applicants who meet the first paragraph of the second point, the Office of Research and Development will in principle export the list of works from the Yuntech Teacher's Works Catalog System in May each year and calculate the incentive points, and send it to each department office to transfer to the applicant for confirmation, in order to handle the incentive payments; the exported data is based on the review by the Office of Research and Development, and the applicant may not directly modify or supplement the application for incentives.
- (2) Applicants who meet the second paragraph of the second point must attach an application form (Form 2) and relevant award certificates, and submit them to the Office of Research and Development for application and review.
- (3) If there are two or more teachers listed as authors at the same time, they cannot submit duplicate applications.

VII. Letters, short articles, or other papers belonging to academic journals shall be subject to review by the Office of Research and Development.

VIII. Papers published in academic journals that fail to use the official name of the country in accordance with government regulations-resulting in the downgrading or misrepresentation of Taiwan's national status-will not be eligible for incentives. Examples include: Taiwan, China 、 (City Name), China 、 (Academic Institution Name), China 、 People's Republic of China 、 Chinese Taipei. Furthermore, if the applicant's paper includes multi-affiliation authorships but the individual has not obtained proper approval through the university's administrative procedures-such as part-time work, secondment, joint appointments, collaboration, research leave, or further study-the paper will not be eligible for incentives. Those who use false documents, forge documents or other violations of academic ethics that damage the reputation of the university, Yuntech may recover all the paid amounts and handle them according to relevant regulations.

IX. These guidelines are passed by the administrative meeting and the University Fund Management Committee, and submitted to the President for approval, and the same applies to amendments.
